

PICTURE POLICIES

Foreword:

DreamNation's Picture Policies are designed to provide a balance between what we, as residents, would like and what is fun, and what is safe for the grid and the residents. In the immortal words of John Kennedy, it is not about what the grid can do for us, but what we can do for the grid.

The picture policies are not only about the law, especially what is the law in the USA, but also about doing what we can to keep our grid, our DreamNation, alive and well, and provide a safe and secure environment for all our residents.

We are looking for you to use common sense in accepting and abiding by these picture policies as your way of assisting us in keeping our grid, safe, secure and fun.

Definitions:

Artwork means any object uploaded to our server, be it in your inventory and/or in a region, such as but not limited to pictures, drawings, sculptures, etc. Included are photographic, drawing and CGI generated images, cartoon as well as life-like.

Minor means anyone who is or appears to be under 18 years old.

Management means the managers of KatWaki Entertainment LLC who are currently Waki Janus and Kunta Kinte.

In all cases, DreamNation management reserves the right to have the final decision as to whether the given item is allowed or prohibited, although they may change any decision at a future time as they see fit. DreamNation Management reserves the right to demand the removal of any artwork it regards as putting DreamNation at risk.

Artwork Policies:

- 1. CHILD PORNOGRAPHY IS TOTALLY PROHIBITED IN ANY ENVIRONMENT.**
If you don't know what constitutes Child Pornography then find out. Again, if you think what you have might be Child Pornography, then most likely we (the Management) will too and so will the law. Possession of it (even if not displayed), or offers to trade it, are not only PROHIBITED ON DREAMNATION, but are ILLEGAL. Doing so on DreamNation will result in an instant and permanent BAN.
- 2. REAL LIFE ARTWORK OF NAKED MINORS**
Artwork that includes or portrays naked real life Minors is TOTALLY PROHIBITED in DreamNation.
- 3. REGION CATEGORIES**
Our regions are classified into three different categories. The policy is different for each category.

A) PG Regions:

- i) Artwork of real life Minors and artwork depicting Minors is allowed as long as the Minors are suitably clothed, do not depict or display the Minor with sexual or erotic intent, and does not have a purpose of objectifying Minors.
- ii) Artwork of any kind, including virtual life avatars, that depicts a sexual activity or a scene that is of an indecent sexual manner or context is prohibited.

B) Mature Regions:

- i) Artwork of real life persons who are Minors, artwork including CGI imagery depicting Minors are allowed provided, at a minimum, that the below guidelines are followed.
- ii) The following provide guidelines to what is NOT acceptable:
 - a) Real Life nude minors
 - b) does not not show head or face of a minor
 - c) focuses unduly on body parts of a minor
 - d) obvious sexual arousal of a minor even when clothed such as tenting
 - e) depicts clothed minors in a sexual manner or context
 - f) depicts a minor engaged in a sexual activity or depicts a minor in an indecent sexual manner or context
 - g) depicts the minor with sexual or erotic intent
 - h) has a purpose of objectifying minors

C) Adult Regions:

- i) The following guidelines apply to Adult Regions or parcels on those Region that are open to all members of DreamNation:
 - a) Illustrations, paintings, sculptures and other works that are generally regarded as fine art that portray nude minors are acceptable;
 - b) 2D Art, ie. any Non-computer Generated Image that is most commonly drawn by hand in a cartoon fashion, is generally acceptable as long as it does not depict extreme violence on, or rape of minors;
 - c) CGI Imagery that focuses on portrayals of romantic love or naked innocence will be generally acceptable but will be reviewed on a case by case basis.
- ii) Adult Regions that are restricted entry to invitation only groups or individuals may display artwork depicting minors including drawn art, cartoon art and CGI as long as:
 - a) that artwork is not regarded as child pornography under US Federal Laws including past and future legislation of the US Congress and past and future rulings by US Federal Courts.
 - b) that artwork is not visible from any other region or parcel that does not have the same access restrictions.

4. MANAGEMENT REACTION AND ENFORCEMENT

A) Child Pornography:

will result in an instant life-time ban and deletion of material with no right of appeal.

B) All Other Cases:

The Management will ask for the removal of the offending content from both display and the Resident's inventory. The Resident will have a reasonable time to comply. If the Resident does not comply the Management will remove the offending content.

C) Repeated Violations:

May result in deletion from inventory of the offending content, notice of intention to apply suspensions, and bans of a limited time. This may lead to a permanent ban if Management believes the Resident in question is willfully breaching policy.
